## **Instructions for online Vitals Request:**

- Birth records are confidential and not open to the general public, except for those that are at least 100 years old. Who is entitled to obtain records:
  - You if you are 18 years of age or older, or an emancipated minor, in which a court order would be required
  - Parents/grandparents
  - Adult children/grandchildren
  - Adult siblings
  - Spouse
  - Legal guardians or legal representatives (proof of legal guardianship/representation also required

Proof of relationship may also be required.

## All requests must be accompanied by a copy of your valid ID.

- Birth, Death and Marriage Certificates are all \$5.00 each. Make sure to enclose \$5.00 per requested copy.
- Please send a self-addressed stamped envelope for the certificates to be mailed to you.
- Send back page 1 and 2 of the application with your money and envelope to our office.
  We will process as quickly as possible.
